## MUDGEERABA SHOW SOCIETY LOCAL BUSINESS EXPO CONTRACT TERMS AND CONDITIONS

- 1. APPLICATION & SITE FEES: All Site Applications will be received and considered against selection criteria based on past performance, attraction and/or value for money. Please submit your application as soon as possible, with full details, but please DO NOT make any payment until you receive confirmation that your application is successful. Late site applications will only be considered for approval on merit. Site fees are non-refundable.
- If the full remittance is not received by the due date, the Society reserves the right to re-let the site referred to on such terms and conditions as the Society may determine and this contract shall be void and of no effect..
- 2.. PASSES: Your Site includes ONE adult entry pass for Sunday. (non-transferrable). Additional one-day passes are available for \$15.00 each. (Limits apply).
- 3. CARPARKING: Carparking for Local Business Expo siteholders is located opposite the Showgrounds off Mudgeeraba Road, (Mosaic Church entrance.). Car Park fee is \$10 per vehicle. Please see website for Park & Ride locations.
- 4. INSURANCE: The Show Society requires that each siteholder must carry Public or Legal Liability Insurance.
- A Certificate of Currency must be provided with your application and must show the following:
- (i) The insured's name must be the same as the name on your site application.
- (ii) The period of insurance must cover the duration of your time on the grounds.
- (iii) Public Liability Insurance of \$20,000,000 minimum.
- (iv) Your Certificate of Currency should indicate that your policy covers you at the Mudgeeraba Showgrounds or Anywhere in Australia. PLEASE NOTE: It is the responsibility of the siteholder to ensure that your Public Liability Insurance Policy covers your activities at the Mudgeeraba Showgrounds for the duration of your time on the grounds. A copy of any part of your policy or renewal document cannot be accepted in lieu of a Certificate of Currency.
- 5. **HEALTH REQUIREMENTS**: Siteholders must abide by any applicable health directives set down by the Chief Health Officer.
- 6. VEHICLES/ACCESS: Access to the site for setup is available from Sunday morning from 6am. Your bump in time will be communicated to you from the Site Manager. Failure to adhere to bump in time slots may result in forfeiting your preferred location. No delivery vehicles will be allowed access to the grounds on Sunday during show open times. There will be NO EXCEPTION to this rule due to liability regulations. Siteholders will not be permitted access to their sites until all site fees are paid in full and all required documentation has been received by the Show Manager. The Show Society reserves the right to tow away vehicles parked on the grounds during the Show, at the owner's expense.
- 7. SITEHOLDERS shall, at all times, conduct themselves in an orderly manner whilst on the grounds and shall be responsible for the actions of their employees and volunteers.
- 18. Under the Licensing Act, no alcohol is to be brought onto the grounds.
- 19 Siteholders are not permitted to conduct raffles or to engage in spruiking.
- 10. Microphones, sound amplifiers and machine demonstrations are acceptable only when the level of sound causes no annoyance to the neighbouring siteholders or the general public. The Society shall be the sole judge as to whether annoyance is being created. In the first instance, such systems shall not be operated without the approval of the Society.
- 11. Siteholders should ensure that they are fully aware of, and that their sites comply with, all regulations and requirements of all statutory bodies.
- 12 Siteholders shall accept the responsibility to remove all rubbish from their site and place it in bins provided.
- 13. Siteholders cannot assign or sub-let any part of their site without the consent in writing from the Society.

14. Displays, stalls or fixtures may not be removed or dismantled before 4pm on the Sunday of the Show. Every display must be fully staffed and operational during the entire period of the Show, from 8am until 4pm Sunday, unless otherwise approved by Mudgeeraba Show Society.

15. The Society accepts no liability for the loss of profit, damage to exhibits by loss, deliberate act, theft, fire, water, flood, storm strikes, riots or any cause whatsoever. Insurance for the loss or damage is the responsibility of the siteholder.

16. The Society reserves the right at all times to postpone or amend the advertised dates for the Show, utilising the right only where circumstances necessitate such action, without any liability to the Society.

17. The Society reserves the right in unforeseen circumstances to amend or alter the exact site or location of any display and the siteholder undertakes to agree to such alterations or re-locations.

18. Sites shall be allocated relevant to each annual Show and the Society reserves the right to allocate each site each year to whomever it desires. Factors such as years of regular attendance will be taken into account.

19. The Society reserves the right to cancel and to retain all monies paid in relation thereto if there is or has been, in the opinion of the Committee, any infringement of any part of the foregoing conditions and/or if the siteholder does not occupy the contracted site at the commencement of and during the full period of the Show.

20. The Society reserves the right to reject any application for a display site or the right to exhibit at its sole discretion and its decision in this regard shall be final. Furthermore, failing to comply with conditions may result in a siteholder being excluded from further shows.

I have read and agree to the Mudgeeraba Show Society's Terms and Conditions. I acknowledge that any breach of these conditions can result in exclusion from the event.
